

# Notice of Privacy Practices Spinal & Sports Care Clinic, PS

Effective April 14, 2003

## To our patients:

This notice describes how health information about you, as a patient of this practice may be used and disclosed, and how you can get access to your health information. This is required by the Privacy Regulations created as a result of the Health Insurance Portability and Accountability Act of 1996 (HIPAA)

## Our commitment to your privacy:

Our practice is dedicated to maintaining the privacy of your health information. Spinal & Sports Care Clinic, PS is required by law to maintain the confidentiality of your health information. Spinal & Sports Care Clinic, PS realizes that these laws are complicated, but we must provide you with the following information:

### Use and disclosure of your health information in certain special circumstances

#### The following circumstances may require us to use or disclose your health information:

1. *Treatment:* to provide, coordinate or manage your health care and related services. Spinal & Sports Care Clinic, PS may consult with other health care providers regarding your treatment in order to coordinate and manage your health care with others. Spinal & Sports Care Clinic, PS may use or disclose protected health information about your treatment activities of another health care provider.
2. *Payment:* Spinal & Sports Care Clinic, PS may use or disclose protected health information so that Spinal & Sports Care Clinic, PS can bill and collect payment for the treatment and services provided to you. Before providing treatment or services, Spinal & Sports Care Clinic, PS may share details with your health plan concerning the services you are scheduled to receive for payment approval.
3. *Health Care Operations:* Spinal & Sports Care Clinic, PS may use or disclose protected health information to allow us to improve the quality of care Spinal & Sports Care Clinic, PS provides and to reduce health care costs, which may include training programs for our staff.
4. Cooperating with outside legal entities.
5. To public health authorities and health oversight agencies that are authorized by law to collect information.
6. Lawsuits and similar proceedings in response to a court or administrative order.
7. If required to do so by a law enforcement official.
8. When necessary to reduce or prevent a serious threat to your health and safety or the health and safety of another individual or the public. Spinal & Sports Care Clinic, PS will only make disclosures to a person or organization able to help prevent the threat.
9. If you are a member of U.S. or foreign military forces (including veterans) and if required by the appropriate authorities.
10. To federal officials for intelligence and national security activities authorized by law.
11. To correctional institutions or law enforcement officials if you are an inmate or under the custody of a law enforcement official.
12. For Workers Compensation and similar programs.

#### Your rights regarding your health information:

1. Communications. You can request that Spinal & Sports Care Clinic, PS communicate with you about your health and related issues in a particular manner or at a certain location. For instance, you may ask that Spinal & Sports Care Clinic, PS contact you at home, rather than work. Spinal & Sports Care Clinic, PS will accommodate reasonable requests.
2. You can request a restriction in our use or disclosure of your health information for treatment, payment, or health care operations. Additionally, you have the right to request that Spinal & Sports Care Clinic, PS restrict in your care or the payment for your care, such as family members and friends. Spinal & Sports Care Clinic, PS is not required to agree to your request; however, if we do agree, we are bound by our agreement except when otherwise required by law, in emergencies, or when the information is necessary to treat you.

3. You have the right to inspect and obtain a copy of the health information that be used to make decisions about you, including patient medical records and billing records, but not including psychotherapy notes. You must submit your request in writing to our Privacy Official: *Kelli Lewis*.
4. You may ask us to amend your health information if you believe it is incorrect or incomplete, and as long as the information is kept by or for our practice. To request an amendment, your request must be made in writing and submitted to our Privacy Official: *Kelli Lewis*. You must provide us with a reason that supports your request for the amendment.
5. Right to a copy of this notice. You are entitled to receive a copy of this Notice of Privacy Practices. You may ask us to give you a copy of this Notice at any time. To obtain a copy of this notice, contact our Privacy Official: *Kelli Lewis*.
6. Right to file a complaint. If you believe your privacy rights have been violated, you may file a complaint with our practice or with the Secretary of the Department of Health and Human Services. To file a complaint with our practice, contact our Privacy Official: *Kelli Lewis*. All complaints must be submitted in writing. You will not be penalized for filing a complaint.
7. Right to provide an authorization for other uses and disclosures. Our practice will obtain your written authorization for uses and disclosures that are not identified by this notice or permitted by applicable law.

*In accordance with the standards of implementation specifications of 45 C.F.R. § 164.524, Providers may grant an individual access to inspect and obtain a copy of protected health information about the individual in a designated record set.*

**Spinal & Sports Care Clinic, PS's policy:**

1. The designated record set that is subject to access by an individual is as follows:
  - a. Medical Records
  - b. Billing Records
2. The title of the person or official responsible for receiving and processing requests for access by individuals is as follows:
